- 5. DISCUSSION ITEMS
 - 5.1 Inclusion of secondary responders on the LA-RICS network.

Captain Edson stated that previous LA-RICS JPA meetings minutes do not appear to acknowledge that the LA-RICS solution would support the secondary responders. He believes the RFP should include a capacity that will support secondary responders, and that the JPA should acknowledge the LA-RICS solution is in fact for first and secondary responders.

Executive Director Pat Mallon was asked what defined secondary responders. He suggests all municipal resources can be brought into the picture. He also stated there are 17,000 for secondary responders and 34,000 for first responders.

Concerns arose regarding spectrum and secondary responders. A few of the Committee Members expressed that if there was a major incident, the understanding was that LA-RICS would provide most amount of coverage to the first responders at that time. They questioned that if that would negatively affect the secondary responders and not be able to provide coverage as anticipated. The original concept was that second responders would be on a different system, so they would not be using the resources from LA-RICS.

Executive Director Mallon stated the majority of the current secondary responders will be on the T-Band system. Within the hybrid digital trunk system, T-Band can support secondary responders. Those that are not within the T-Band and those that will be migrating off the T-Band into the 700/800 MHz will have two systems available within LA County: 1) the LA City STRS; and 2) the LA County CWRS. Those resources can be used to support secondary responders in T-Band, as well as longer term.



Committee Member Mehrdad Larijaniha, LA City Sr. Engineer, stated that rather than having solutions proposed it would be prudent for LA-RICS to allow the industry to recommend the solutions. The industry can assess what is needed by knowing the intent and design that needs to be accommodated into one platform. Based on what resources there are, they can recommend the solutions based on the frequencies that are available. If there are no potential frequencies available to public safety or even the secondary users, then they can offer additional frequencies that can be procured if needed.

Committee Member Dave Keetle reiterated the project should ask for the ideal system with everything on it before running solutions and alternatives if it does not work. Present the ideal system, have everyone work on it, and then give it to the industry so they have an opportunity to decide if it will work or not work, then go to the alternative radio system.

Captain Edson made a motion that both committees recommend to the JPA Board they support the inclusion of secondary responders, as defined as municipal resources, on the LA-RICS network. **MOTION APPROVED.**

5.2 Operational needs/requirements of analog channels.

Captain Edson stated that all previous RFP's have included the need for analog conventional channels.

Executive Director Mallon stated that LA-RICS sent out a questionnaire asking for municipalities to indicate what their ACVS requirements would be. There is a wide variation in perception as to what the LA-RICS system will provide. Many of the cities that are currently operating on the UHF system gave different channels which they are currently utilizing for their operation, municipal dispatch, as well as talk-around. In many cases what each city needs in the way of analog channels or system, is the same number they currently have. In only one case did they request more analog channels than they currently had, and that is in addition to the digital trunk-system. There seems to be sufficient spectrum within the county and maybe even within the state to provide that. What LA-RICS suggests to the Technical Committee is that the county be divided into three to five sections and offer a pool of analog channels to the municipal agencies for use at five channels per area, and if we exceed the requirement for that because of some special operation, we have to fall back to the LARTC system. It was stated that one channel per independent city would suffice, with the exception of Long Beach and Los Angeles, which would need some additional channels due to the size of the operation.

Captain Edson stated the digital trunked-system has an "X" number of channels and each city has their dedicated trunk, and if they have a tactical need there are digital



trunked system channels available for that need. Therefore, the analog channels are in addition to those channels on the digital trunked system.

The Operation Committee will have to address some kind of agreement between all of the users as to the definition of what those analog channels are for, in order to avoid having some agencies using them for their daily operations.

Executive Director Mallon stated that right now LA-RICS is looking at five for each. There is no formal commitment on spectrum at this point, therefore, as members commit as a subscriber to the system.

Captain Edson stated that LA-RICS is looking at the minimum requirements and the ability to expand as additional requirements arise.

Executive Director Mallon provided an RFP schedule:

- October 4, 2012 Go before the JPA and ask them for their authorization to the release the RFP once it is reviewed.

COMMITTEE RECOMMENDATION ON TECHNOLOGY AND OPERATIONAL OPTIONS

RECOMMENDED ACTIONS

It is recommended that the Committees:

- Provide input regarding the Authority's option to procure Additive Alternate 1 Home Subscriber Server, from the Public Safety Broadband Network (PSBN) proposed contract; and
- 2. Provide input regarding the Authority's option to procure Additive Alternate 2 Redundant Evolved Packet Core from the PSBN proposed contract; and
- 3. Provide input regarding the Authority's option to procure Additive Alternate 3 Location Services from the PSBN proposed contract;
- 4. Provide input regarding including Capital Replacement / System Refresh for the PSBN in the Draft Proposed Funding Plan; and
- 5. Awarding the PSBN Proposed Contract with Motorola Solutions, Inc.

BACKGROUND

On February 20, 2014, the LA-RICS Board of Directors requested input from the Technical and Operations Committees regarding PSBN uses, the status of the PSBN, and direction from the Committees as it relates to technology and operational options included in the Draft Proposed Funding Plan for the Long Term Evolution (LTE) portion of the LA-RICS System. In addition, at its February 26, 2014 meeting, the Finance Committee requested direction from the Technical and Operations Committees on the various options included in the Draft Proposed Funding Plan.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Televate, the Authority's broadband engineering consultant, has prepared a presentation to address the technical and operations options identified above. Discussion and recommendations are requested from your committees, for each of the above-mentioned items, separately.
