This Notice to Proposers "A" is issued on behalf of the LA-RICS Authority and clarifies information contemplated in the Request for Proposals (RFP) dated August 15, 2018, and also includes questions received in writing from potential proposers and answers in connection with the same, all of which is hereby made a part thereof.

#### **CLARIFICATIONS**

- It is the expectation that the awarded Consultant will work intimately with LA-RICS Authority staff (who are largely employees from the member agency, Los Angeles County, who are on loan to the LA-RICS Authority) and its consultants such as Jacobs Project Management Co. and Televate, LLC, as well as other member agencies representing various independent cities where sites are contemplated.
- 2. Please note that Section 1 (General Work and Team Structure) of Exhibit A (Scope of Services) to the RFP stipulates the awarded Consultant will be contractually obligated to render a variety of professional engineering design services and work, which includes, but is not limited to, "Specification Preparation." The specification documentation, although not listed as a stand-alone Deliverable, will be required for each site as part of the drawing process and Deliverables contemplated in Exhibit A (Scope of Services) to the RFP.
- 3. Please note that Section 11 of Exhibit A (Scope of Services) to the RFP requires the awarded Consultant to include applicable Construction Management Requirements (CMRs) into its project design features, such CMRs will be identified by the LA-RICS Authority and provided to the Consultant for inclusion into the design. The awarded Consultant is not required to perform any environmental work as part of the resultant Engineering Design and Related Services Consultant Agreement.

Attached to this Notice to Proposers "A", is the LA-RICS Authority PSBN Round 2 Site List (Attachment 1), which identifies, at a high level, the list of potential sites and the respective site types. This site list is very preliminary and is being provided for informational purposes only and is subject to change at the LA-RICS Authority's sole discretion.

### **QUESTIONS AND ANSWERS**

Question 1: In connection with this engineering design services RFP, what is the

estimated value for construction of the resultant Public Safety Broadband

Network (PSBN) Round 2 buildout?

**Answer:** It is estimated that the construction value for the PSBN Round 2 buildout

will be between approximately \$9 – \$14 million dollars.

Question 2: How many different construction firms is the LA-RICS Authority expecting

to perform the construction portion of the PSBN Round 2 buildout?

**Answer:** At present, the LA-RICS Authority doesn't have an exact number of how

many construction firms will be constructing the PSBN Round 2 buildout, however, it is estimated to be between approximately 2 – 4 construction

firms.

Question 3: We request the list of firms who were awarded on PSBN of previous 72

telecommunication sites. If these firms are submitting proposals for the

new 26 telecommunication sites, we would like to be their subcontractors.

**Answer:** Motorola Solutions, Inc. (Motorola) was awarded the PSBN contract and

was the prime contractor who was responsible for performing the PSBN Round 1 buildout. Motorola did have a number of subcontractors. The LA-RICS Authority does not know what firms will be bidding on resultant

construction solicitation(s) for the PSBN Round 2 build.

Proposers are encouraged to notify its subconsultants of the information contemplated in this Notice to Proposers "A."

Except as expressly modified or clarified by this Notice to Proposer's "A", all other terms and conditions of this RFP shall remain unchanged.
